Officer Harrington and I were aware of the two occupants of this residence from a run earlier in our shift. I heard loud banging and yelling while I was at the front door waiting for it to be opened. Robert opened the door, and I could see his wife, Barbara, in the kitchen throwing a pot onto the floor. I also observed a number of bleeding cuts on Robert's arms. Robert attributed the injuries to his dog jumping on him and his use of blood thinners causing him to bleed easily.</p> <p>Based on the previous run, I knew Barbara to be suffering from memory loss and generally very confused about the present. Barbara had walked out of the house and knocked on her neighbor's door, emotionally distraught and confused. On that run, Sgt. Elfreich found Robert unconscious in the backyard of their house. After being woken up, Robert seemed fine, and we brought Barbara back home. Robert said he was acting as Barbara's caregiver.</p> <p>Upon entering the house during the second run, we noticed the poor conditions of the residence. There was a large amount of clutter that made it difficult to navigate and caused many tripping hazards. As well, there was broken glass strewn throughout the house on surfaces and the floor. There was trash spread throughout the home. The conditions can be observed through officers' bodyworn cameras.</p> <p>Barbara was fully cooperative and polite to officers, but she was very confrontational with Robert and raised her voice at him while we were in the house.
