Missouri St. Officers called off on investigation near the above area in marked patrol car 1907 and in full uniform.

When Ofc Christian pulled into the alleyway he observed a purple car, IN plate CYT467, blocking the alley with multiple subjects standing around the vehicle. When Ofc Christian exited his vehicle OF, Kortney Harper, attempted to walk away. Ofc Christian gave all subjects on scene verbal commands not to leave the area. Ofc Christian called for another car to assist due to subjects moving around due to his presents on scene. Through training and experience, the area being known for drug use and high crime, Ofc Christian believed crime was afoot during his investigation.

Kortney was given multiple commands by on scene officers to stop trying to walk away but she refused to obey. Kortney began to walk away eastbound towards the next road over. Ofc Christian grabbed Kortney's right arm but she pulled away and continued to walk away. Ofc Christian grabbed Kortney's right arm again and she tensed her arm while trying to pull away. Ofc Christian used force to place Kortney under arrest for resisting law enforcement.

During incident to arrest, Ofc Christian located a glass smoking device with burnt residue inside of Kortney's jacket pocket. Ofc Christian also located a plastic container with a crystal like substance inside on Kortney's person as well. The crystal like substance tested positive for methamphetamines with a field weight of 4.83 grams. Through training and experience, the glass smoking device with black residue is used to ingest illegal narcotics.

A supervisor arrived on scene to interview IO1, IO2 and Kortney before being transported to VCJ for booking.

Officers were dispatched to a check welfare. The reporter stated a male was twitching and laying on the ground. Caller thought it might be having a seizure.

Officers arrived and were directed to where the male was sitting. The male was swaying back and forth and had slow slurred speech. Officers informed him why they were there and had him stand up. He swayed on his feet and struggled to follow directions at first. Officers gained consent to search his person and located a black bag in his right change pocket. They placed the male in handcuffs. A metal one hitter with burnt residue was also located on his person. He stated he used that to smoke his narcotics. The male identified the substance in the bag as K2. It later tested positive for synthetics weighing in at 0.7 grams.

The male was given a citation and released from the scene. Officers later placed the said K2 and one hitter into evidence.
