While officers were outside of the Ford Focus they could smell a strong odor of marijuana coming from the vehicle.</p> <p>Officers then made contact with the other occupants that were inside the vehicle in the Circle K. When officers made contact with the other two females they were standing outside of the bathroom. The male then came out of the bathroom and all three were placed into custody. Officers detained all three subjects and placed them into handcuffs.</p> <p>Inside of the bathroom officers could smell an odor of marijuana. Officers located grey plastic baggie that contained a green leafy substance. The green leafy substance later tested positive for THC with a field weight of 6.4 grams. A female later openly admitted without questioning that it was her marijuana in the bathroom. Officers conducted a probable cause search on the male and located two black and gold THC pens.
